# **Leadership and Administration**

### The Rector's Report

The Venerable Dr. David J. Anderson

When the coronavirus COVID-19 pandemic began none of us could have ever imagined that almost two years later the public emergency would continue to affect us all so deeply. To say that this has been an unprecedented experience within our lifetime is an understatement.

As we look back over the year past, we have much to be thankful for. The ministry reports contained here detail the substantial activities and ministries of the parish that have continued throughout this difficult time, in many cases responding to the challenges of these days.

The generosity of parishioners has enabled us to continue many of our vital ministries without the necessity of laying off staff or other cuts that would limit our abilities to carry on. Without gathering for Sunday worship, the parish has, of course, seen a reduction in income that would normally arrive on the offering plate. However, many envelope givers have maintained their giving by dropping checks in the post or in the parish mailbox. Those who give by preauthorized giving through their financial institution, or by e-transfer, or online giving, have increased. The steadiness of these gifts has been sustaining for our ministries.

My annual report gives me the opportunity to offer public thanks to those who have led and contributed to the life of the parish in particular ways. I am always grateful to the churchwardens of the parish who share with me responsibility for the fabric of the church and who offer special council and leadership in our parish. I want to especially thank **Margaret Wilding**, who after several terms is coming off corporation. Margaret brought a number of gifts to our councils. Never afraid to think out of the box she could be counted on to bring a unique perspective that often forced us to rethink our assumptions. She was consistent in reminding us to rely on God and commit our work to prayer. I am grateful that Margaret will remain a member of Parish Council in 2022.

We have been blessed with pastoral interns in 2021. Nicola Zhang continued with us until the end of April, having joined us in 2020. Nicola continues her formation as a candidate for ordination in the Diocese of Niagara. We were pleased to welcome Tom Hubschmid as a pastoral intern January of 2021. Tom has been discerning a call to the priesthood as a candidate for ordination in the Diocese of Calgary and has recently received the news that, God willing, the Bishop of Calgary will ordain him to the Holy Order of Deacons in May of this year. Please join me in congratulating Tom and in praying every blessing on his ministry. Tom and Tanya have plans to be in Alberta for the summer, but to return to Ontario in the Fall. We hope that we will be able to connect again at that time.

I would like to offer a special word of thanks to Barbara Ruttan and the amazing team who gave shape to our most recent refugee sponsorship. The project was amazingly successful, especially given the unique challenges posed by the pandemic. Many people brought diverse gifts to the

table, from the provision of temporary housing for the initial period of self-isolation, to cat-sitting; from helping the newcomers become acquainted with public transit, to helping them find employment, and permanent housing; from language translation to assistance with setting up their apartment. Special thanks as well to the teams that conducted two very well-received fundraisers: JustArt and JustDinner. These events not only raised significant funds for the project, but elevated the profile of our parish in the community. We are grateful that Shakiba, Laya, and Mona are off to such a good start in their new life in Canada.

I also want to say a word of thanks to our parish staff. I am very grateful that our musical leaders, Gareth Inkster, and Paul Grimwood, have stuck with us during this strange time. I am thankful for their partnership in leading worship and their friendship with us all.

Many of you reading this report may not have met Frances Ward, our parish administrator, who is in the parish office each Thursday. Frances looks after the office with terrific efficiency, answering the telephone, responding to messages, dealing with the mail, and looking after our bookkeeping. Much of her work is unseen by most of us, but I assure you that her work is critical.

I also want to say thank you and a welcome to Daniella Cruz who joined our staff late in 2021 as our new Coordinator of Children's, Youth, and Family Ministry. She is a delight! The Christmas Pageant video she produced with the children of the parish was a tremendous success and the highlight of what turned out to be a rather muted Christmas in 2021. The pageant included music from the Children's Choir, directed by Susan McKay, and was filmed on location at Paul Grimwood's "Bethlehem" farm.

We have a challenge ahead of us in 2022 as the reopening for public worship and other programs lay ahead of us. We look forward especially to the resumption of children's ministry activities, especially our Children's Church programs on Sunday mornings. All of this will be dependent upon each of us who volunteer and offer our own gifts of ministry in the life of the church for our common good. The work of the church requires the participation of all of us in the ways that God has gifted us. Please pray and consider how you can be part of our reopening in the coming months.

As I do each year, I want close by thanking each and every person who makes Saint John's their church home. It is my great privilege to be your parish priest. As we have begun to develop a new Mission Action Plan in 2022, I am excited about our future. By the numbers who attended our first consultation and the quality of our discussions, I sense that you are feeling excited too. I firmly believe that God is calling us to live more fully into God's mission in our neighbourhood, contributing to the flourishing of life here in our neighbourhood and city. I am encouraged by how we are answering that call and how God seems to be equipping us to grow deeper into that vocation. Bless you all.

## **Pastoral Visiting**

### Susan Little and Patti Troughton

Under the direction of the Rector, we (Susan Little and Patti Troughton) are entrusted to visit members of our parish who are unable to join Sunday or mid-week worship. While this ministry often takes place in a retirement home or long-term care setting, most of our visits occur in a parishioner's home. Sometimes we make hospital visits. With three waves of COVID-19 occurring throughout 2020-21 and concluding with a fourth wave as 2021 ended, our visits have taken different forms.

As 2021 began, we continued doing telephone calls and monthly notes to keep in touch with our members. Unfortunately, over the course of this year, a few of our dear parish members have died and we were unable, because of COVID restrictions, to publicly grieve their passing and celebrate their lives. However, where possible, the Pastoral Team has continued to reach out to the remaining spouse and families over the months thereafter.

In 2021, we delivered to our people Easter and Christmas goodies, hoping to raise their spirits and to remind them of how much their parish family misses them on these holidays. Through the intervening months, we have maintained regular contact through notes and cards as well as the weekly telephoning following the Parish Cycle of Prayer. Patti telephones all the people mentioned in each week's intercessions during our service. Although each person we contact through telephone or note is different, their response is always heartwarming. Such work is always time well spent. With the advent of vaccinations and booster shots, we have been able to visit in the fall and early winter and share the blessed sacrament (bread only). As 2021 drew to a close, so did our opportunity for personal visits and we await a better year for visiting in 2022.

Beyond the work the two of us do, there are parishioners who continue to do pastoral work by routinely keeping in touch with members of our parish family who have been unable to come to church both before and during COVID-19. Several people have been doing this, long before the pandemic.

There is also a large number of people who have been keeping in touch regularly with other parish members throughout COVID-19, encouraged by Parish Council and the Rector to connect with one another. Like good brothers and sisters, they have been reaching out and trying to maintain relationships from 'normal' times together. Such people among us are precious because they continue to share in the lives of people they know and people whom we all miss. Thanks be to God for those who continue to take the light of Christ into lives of others. This is what being 'family' is all about!

We are grateful that through these ways many among us are able to serve our parish family in God's name.

### Revive

The Revive program developed by the Reverend Canon Dawn Davis and resourced by the Forward Movement. Revive is intended as a short course in spiritual practices in three modules: (1) prayer; (2) bible reading; and (3) Christian vocation. We were pleased that we were able to continue Revive in 2021, having completed all three modules. We are aware that not everyone who began Revive has had the opportunity to participate all of the modules. I plan to offer another round of Revive in the Fall of 2022.

### Be Hive

Over the past year of 2021, BeHive has continued with its six members and adapted to Zoom and teleconferencing.

Gathering bi-weekly at 6:30PM on Mondays, we have met by Zoom, hosted by Sue Newbery for ninety minutes or so for most of the year. As the 2021 began, we found ourselves deeply engaged with the study "The Twelve Disciples". When COVID restrictions lifted in the summer, we were able to gather in person and socially distance as we studied "Integrity". This study consisted of a variety of biblical principles using different sources of both Old and New Testament scripture. Interestingly, as the daylight waned so did the health of our society so our group was chased back to the indoor zooming format for the remainder of this study. We then studied "The Advent of Our Saviour" as Advent began and its detailed look at different aspects of the Christmas Story (from the annunciation to the appearance of the Magi) took us into 2022.

Zooming has enabled us to grow in ways which surprise us. We have become more earnest in praying for one another's concerns and more deeply connected as Christians journeying together. Although one of our members has found too many challenges in meeting virtually, we have found ways to continue this person's study using a different model.

We find our study sessions to be a time which stretches our understandings and provides us a safe place to share our lives and concerns. Our time together knits us together as we conclude with prayer each night for both personal and parish needs. More importantly, it propels us to discover more ways that God engages us to love learning and to grow closer to Him by serving others.

## **Prayer Team**

Over the course of 2021, there has been no opportunity for Prayer Team to operate since the protocols of social distancing conflict with the intimacy required in praying together as practised at the Baptistery at both the 9:30 and 11:00AM services. Although saddened to provide no Prayer Team presence at services that occurred in person during the summer and fall, the Prayer Team members look forward to a brighter 2022.

This ministry of private intercessory prayer is carried out by a faithful team of people possessing this gift and have been commissioned each September to serve each Sunday at both the 9:30 and 11:00 a.m. services. They lift up prayers on behalf of individuals with specific needs or thanksgivings. They also lift up the unspoken needs of the rest of our parish family.

Although it is not under the umbrella of The Prayer Team, the Parish Prayer Chain has continued to function throughout the pandemic so to serve the on-gong needs of our parish. We thank the various members of the Prayer Chain for their faithfulness and private prayer. It has continued to function throughout 2021 as a lifeline for those with pressing prayer needs.

### **Hearts and Minds**

Hearts and Minds is an informal group, meeting monthly on a Friday evening, to hear a member of the congregation or an invited guest respond to the key question, "How do you live out your faith through your daily life and work?"

Hearts and Minds is in its tenth year, after being restarted in the summer of 2012. This group enables us to share faith journeys in an intimate setting, as well as often acting as a catalyst for new experiences or ministries. Since there is no expectation to attend regularly, most people choose to attend based on the specific topic of the evening; this makes for a variety in clientele, which we see as a good way of fostering community between different groups.

We aim to balance church members as speakers with some invited guests, and individual speakers with panels, on a range of topics and experiences. Again, this year, due to the COVID-19 pandemic and the public health restrictions, we had to offer sessions virtually. While many have missed our usual potluck suppers, there have been some benefits to meeting virtually: (1) some parishioners who might not have been able to come to an in-person session were able to attend the sessions via zoom (we've even had a few visitors from thousands of kilometers away!); (2) having people attend from the comfort of their own homes has been helpful in inclement weather; (3) using a virtual platform has made it easy to record sessions so that those who missed the event can watch it later.

The committee is responsible for organizing the schedule for the year, promoting the sessions, communicating with speakers and hosts, facilitating the sessions, and thanking the speakers. Our committee presently consists of Deborah Bowen, Adrienne Devins, Rebekah Parkinson, and Jenna Wilson, with Tamara Watson designing our bookmarks and posters.

We were very sad to say goodbye to Brittany Friesen when she moved to Kingston in August; she was a creative and energetic member of the committee, but her place has been taken by Jenna, who is wonderfully creative and energetic too!

# Wednesday Lunch

Through the late spring of 2020, when COVID-19 lock down measures allowed people to gather in groups no larger than twelve and stay six feet apart outside, a few parishioners who live in Artaban Place invited people from the parish to have lunch with them. Of course, bringing a lawn chair along with their own lunch, the Wednesday Luncheons began.

Meeting on the green space behind Artaban Place, the gathering began at noon and ended about an hour later, with participants being free to come and leave as needed. With mask and lawn chair, this group usually attracted about four to ten people. When we were close to our quota, people offered to leave so others could attend but those occasions were few.

At each gathering, there was always news to exchange and information to share and the hour or so spent together never failed to boost people's spirits. Simply social in scope and intention, it successfully drew the people who felt they needed to socialize safely.

Interestingly, when rain showers were predicted, the clouds usually lifted around mid-day, long enough for the Wednesday Luncheon to happen and then close in again around 2 pm. Even the sunshine and windy days co-operated.

When autumn arrived, this group moved to the front part of the church on the sidewalk between the east and west doors to enjoy the warmth of the sunshine. As winter and COVID-19 restrictions grew, the group suspended their social gathering until the spring of 2021 arrived and restrictions lifted. The cycle repeated itself in 2021.

This group met last as the month of December arrived but it hopes to re-form when spring of 2022 arrives along with new social gathering sizes and the opening up of society again.

Thanks be to God for just being able to gather! It's so good for body and soul of the Body of Christ.

# Children, Youth, and Family Ministry

I have been blessed to be the Children, Youth, and Family coordinator at St John's since October 25. During this short period, I have met families, parishioners, and volunteers that make St. John's this resilient and beautiful community.

Unfortunately, the pandemic and its restrictions caused us to reshape some of our vision and plans for the ministry. Still, we are confident that, by working together and trusting God's direction, we will be able to meet in person again soon.

The contributions of our Children's Choir conductor, Susan McKay, and of our faithful volunteers Susanne Adams and Susan Little, were crucial to helping to put together our own Christmas Story/Christmas Pageant video, which was recorded in November at Paul Grimwood's property. The credits at the end of the video highlight all the efforts of many wonderful people and families to make this happen. Besides the recording of the video, we were also able to offer 15 boxes containing activities and devotionals for families, to be done during the Advent Season. Our precious children and youth were also gifted Christmas books after their participation on the Christmas Pageant.

The Youth Ministry, led by Margaret Wilding, met faithfully online and outdoors during the pandemic, supporting each other in their walk of faith. They also met in person last year to write Valentine's cards to the tenants of Indwell, a Christian charity that creates affordable housing communities that support people seeking health, wellness and belonging.

One of my priorities as the coordinator of this ministry is to grow in faith and knowledge to better serve our community. I have been blessed to attend the Toronto's Children Ministry Conference online in November, and to network and connect with other CYFM coordinators across our diocese. We are also constantly updating our website with resources for families and checking in with people through the phone or email. These are hard times, with many adjustments and uncertainties; we pray that families, especially with young children can navigate smoothly the switching between online and in-person learning.

# Scattered Children's Library

The library was created Spring 2020 during the COVID-19 pandemic. A series of new books were purchased over the past two years to expand the current Church school library.

The general age range of the books starts at age 2 to 10 years.

The books are delivered to the families in a sealed plastic bag. Books are then picked up and a new set of books are arranged to be delivered. The books are kept in the sealed plastic bag for

approximately 48 to 72 hours and then delivered to your home. COVID-19 Protocol guidelines are followed. The current books are listed on the church website.

Brittany Friesen resigned from our leadership in September 2021 to follow her new vocation. This ministry is presently coordinated by Rebecca Sanfridson and Susanne Adams.

# **Our Life of Worship**

### **Choral Music**

2021 has been another unusual year, with COVID making an impact on every facet of church life.

The first months of the year were a continuation of Christmas 2020. Services were pre-recorded or done live with just a few of us. Lent and Easter did not happen for in person worship. It was not until Thanksgiving that any form of choral music took place on a Sunday morning. The Choral Service alternated with the early service, with an ever-changing roster of twelve singers, until the week before Christmas.

All in-person church services were suspended at Christmas and remain so. During the week leading up to Christmas, Emma Reilly McKay, Katie Weresch, Tim Lo, and Tom Fleming recorded thirteen carols and anthems, which were used over the course of four services.

However, we did sing the Fauré Requiem live on November 11. This was to a "full" church, although that did represent significantly fewer people than normal because of COVID restrictions. We also sang a live, although shortened, shortened Carol Service on December 12. We all miss having regular rehearsals with a full choir, and being able to sing on Sunday mornings, and hope that next year things will return to normal.

David Anderson, who works tirelessly on presenting our Sunday morning services, has been very supportive, and for that, as always, I am very grateful. I'd also like to thank Alex Urquhart for his work in recording all the various presentations - organ only, reduced choir, or quartet. His presence ensures that St John's is not silent.

So far, 2022 has been more of the same. I know how eager everyone is to get back to singing again, and it's difficult to remember a time when this was normal. But with the start of good weather, it seems like it might be possible, even if we don't know when.

### Children's Choir

Due to the COVID pandemic, the Children's Choir did not meet until March of 2021. E-cards and notes were sent to keep in touch with the children and families while we were in shutdown. Once we could meet outside, we recorded "Siyahamba" for Palm Sunday Service. Through April, May and June, we began the challenging process of holding choir rehearsals online. The choristers

shared the canon, "What Does the Lord Require of You" at the June 27 worship service. We are very thankful for Father David's support in recording and preparing the choir anthems for the spring services.

In the fall we initially met in-person at Beulah Park but returned to Zoom due to the colder weather. In October, we were excited to welcome Daniella Cruz as our new Children's, Youth and Family Ministries Coordinator. We were enthusiastic about participating in the Christmas Pageant! The choir contributed "Gloria Deo" to finish the pageant and Miranda Pilcher sang the solo, "Once in Royal David's City" while the credits were playing.

Throughout all of the challenges of this year, our focus continued to be on the choristers' ministry to touch the hearts of those listening and draw them closer to God and Jesus through the beauty of their music. We are very thankful for these seven wonderful children and their faithful parents.

We continue to give thanks to God for Miranda Pilcher's enthusiastic and insightful assistance as youth leader. In the fall, we welcomed Emma Reilly-McKay to the leadership team. Emma brings a wealth of choral experience to our group, and well as her beautiful singing voice. We give thanks to God for Sharon Klassen's musical and technical expertise around zoom and breakout rooms which made online choir rehearsals a possibility. We are thankful for Hal Devins' assistance as a friendly, caring presence on zoom and as security at in-person rehearsals. We also appreciate Paul Grimwood's musical encouragement in the breakout rooms and his generous offers of support.

### Ministries of Outreach

### **Artaban Non-profit Homes**

Artaban Non-Profit Homes Inc. is a non-profit company created by the parish to develop and operate Artaban Place, the twenty-nine unit residence adjacent to the Church. The name, "Artaban," is derived from the name of the protagonist in Henry Van Dyke's book, The Fourth Wise Man, and was adopted as the name of an Anglican summer camp operated in the Dundas Valley from the late 1930s to the late 1960s. This parish had a principal role in the building and operation of that camp, and the name Artaban represents our strong tradition of faith and service.

While the company is legally separate from the Church, the majority of the directors are members of the parish. The day -to -day operations are administered by a property management firm, presently Active Management Ltd., of Burlington; (TAG Management).

The directors meet monthly to review the management of the facility and to provide oversight and policy direction.

As a housing provider in receipt of public funds, Artaban Place does not make private discriminations in the provision of housing, and residents do not have to be members of the congregation. A large number of our apartments provide specially adapted living facilities: twelve are barrier free, three have adaptations to assist people with visual impairment and three to assist people with hearing needs. Artaban Place provides rent-geared-to-income housing on a tight, non-profit budget. To apply to be a resident of Artaban Place, applications for housing are available at Hamilton Housing.

# Refugee Sponsorship

Our formal sponsorship commitment with the our most recent newcomers to Canada, Shakiba, Laya, and Mona, concluded in September of 2021, one year after their arrival in Canada. Despite the challenges of the pandemic, the women have done well in their adjustment to life in Canada. In September they moved to live in Toronto, closer to friends in their Iranian community and in search of better employment opportunities. They are all very happy in their new life.

Thanks to some very successful fundraising and generous donations St. John's was able to fully fund this sponsorship, meaning that diocesan funds for refugee sponsorship will be available for future refugees seeking a new home.

Many thanks to the volunteers who made this project such a wonderful success. It was a great deal of work, but your dedication and collaborative spirit ensured a team approach that made for success. A special thanks to Barbara Ruttan who coordinated the project; Sarah Wayland and Judith Purdell-Lewis, who with excellent teams led our successful fundraisers, "Just Art," and "Just

Dinner"; Kathy Anderson who was in almost contact with the newcomers; and all the many volunteers who assisted in big and small ways with the settlement work.

### **Income-Tax Clinic**

We were fortunate to have two very experienced volunteers (John McBrien and John Prevete) join our team. John McBrien was with us in 2019 and got to know several clients previously. John Prevete joined us as a new Volunteer in 2020. He had previously served as the Co-ordinator of the Volunteer Program in Ottawa ... so he was intimately acquainted with the requirements of the CVITP program. He created a spirited poster for the CVITP and was a great deal of help to me in getting our program to pivot to a Virtual Clinic

Despite this I discovered that it was also difficult for many of our clients to manage the change. Most did not have computers. Others were not able to send text messages. This limited the communication options for those people, and they were reluctant to change how they were used to doing taxes. Consequently, the number of clients served and returns completed dropped drastically to less than 25% of the previous year.

Since we do not know when the Pandemic Restrictions will be lifted this year our Volunteer Tax Clinic is also Virtual. If the Pandemic Restrictions are lifted in 2022 we will consider reopening in the Church at that time.



### **Notes on Financial Statements**

### Section A: Mission and Organization

### A-1: Mission Statement

The mission statement of the Church of St. John the Evangelist is as follows:

God calls us to help people become followers of Jesus, equipped for ministry in the church and in the world, through nurture, worship, evangelism, and service.

### A-2: Brief Description

The Church of St. John the Evangelist is a Christian community of faith and parish within the Anglican Diocese of Niagara in the Anglican Church of Canada, part of the worldwide Anglican Communion. The church was established in 1890 and is located in west downtown Hamilton. The church is a registered charity under the Canadian Income Tax Act. It serves a large population of diverse people who live in the immediate neighbourhood of the church and beyond. In addition to the financial support the parish receives for its work, the parish relies significantly on the voluntary contribution of the times and talent of its members and community supporters. The impact of these non-monetary contributions are fundamental to understanding the Church of Saint John the Evangelist and cannot be measured in financial terms. The annual vestry report which accompanies these annual Financial Statements provides this information to explain and demonstrate the parish's performance in advancement of its shared mission with God.

#### Section B: Financial Statement Notes

#### B-1: Significant Accounting Policies

**Basis of Presentation.** These financial statements have been prepared with accounting standards for not-for-profit organizations. All financial statements are based on the accrual method of accounting which includes the year's cash flows and any amounts owed to and payable by the parish at year-end. Donated assets are accounted for at their estimated market value when donated.

**Fund Accounting.** The parish follows the restricted fund method of accounting for revenues and expenditures. The general fund (not restricted) reports revenues and expenses related to program delivery and administrative activities. All unrestricted investment income is recorded in the general fund.

The internally restricted funds, such as the Endowment Fund, Memorial Fund, Organ Restoration Fund, Parish Hall Capital Reserve Fund, and Capital Fund, report revenues contributed for which their expenditure is restricted by the donors and church policy or until their purpose is completed.

Externally restricted funds, such as the Rectory Fund (restricted by provincial statute and canon law) report revenues contributed for which their expenditure is restricted for specific activities.

Investments. Investment funds held by the Diocese of Niagara are recorded at year-end actual or estimated market value and unrealized gains or losses are accounted for in the related fund. Changes in market value are recognized in the Income Statement as flow-through amounts. When an investment is sold, redeemed, or written off, the actual gain or loss is recognized in the Income Statement for that year.

*Capital Assets.* The church property (land and buildings) are owned by the Diocese of Niagara and therefore not included as assets.

**Revenue Recognition.** Pledges and other commitments to restricted funds are recognized as restricted revenue only when received. Unrestricted contributions are recognized as revenue for operations when received or if the amount to be received can be reasonably estimated and collection is assured.

**Contributed Supplies and Services.** Due to the difficulty in determining their fair financial value, contributed services and supplies are not recognized in these financial statements, nevertheless the real value of these are significant and the operation of the parish would not be possible without them.

#### B-2: Notes on Statement of Financial Position

Audit status. The financial statements of the parish are routinely reviewed by an Auditing Committee appointed in accordance with the Canons of the Diocese of Niagara. The corona virus pandemic has precluded the gathering of such a committee, therefore the statements for both 2020 and 2021 and not been reviewed. The reader should note that the statements within this report are unaudited. The Annual Vestry of 2021 authorized the Parish Council to appoint an Auditing Committee for the purpose of reviewing both the 2020 and 2021 financial statements. A motion will be brought to the Annual Vestry receiving this report empowering Parish Council to do the same, however adding the 2022 statements.

**Investments.** During 2021, the investment funds managed by the Synod of the Diocese of Niagara incurred growth amounting to 13.008%. The status of these funds is outlined in the Statement of Investment Funds, on page 26 above. 2021 proved to be a good year for investments despite the continuing challenges of the coronavirus pandemic. Much of the interest income from investments was transferred back into the various investment funds, meaning that these will potentially continue to produce income for the future.

B-3: Notes on Statements of Investment and Restricted Funds **Rectory Fund.** In accordance with the 2021 Ministry Budget, a draw was taken from the Rectory Fund into the operating account in the amount of \$12,000.

This fund is entirely restricted by civil statute. The first *endowed capital portion* is the original capital from the sale of the parish rectory in the amount of \$180,347.73. The law requires that the endowed capital portion be kept whole in the fund. The remainder of the fund, currently \$59,809.53, is restricted by the same statute for use in support the housing allowance paid to the rector. The growth of the restricted non-capital amount over the past years suggests that the draw from this account could safely be increased for 2022.

**The Capital Fund** is not a segregated account as with the other funds. The Capital Fund is held in the cash accounts. Restrictions within the Capital Fund are outlined in the table, "Capital Fund Designations."

**The Endowment Fund** is internally restricted by the decision of the parish vestry. The vestry policy requires the approval of vestry for the use of these funds. Such approval may be in the form of a ministry budget that calls for a draw from this account (as is the case in the proposed Ministry Budget for 2022) or may be in the form of a separate motion approved by the vestry.

#### B-4: Notes on Income Statement

Offerings (lines 86-91). Due to the coronavirus pandemic the patterns of giving continued to be dramatically altered throughout the year, however donations by Pre-authorized Giving, as well as Envelopes and Other Identifiable Donors increased significantly over 2020. The amounts normally received from Loose and Other Offerings (lines 87, 88) where not realized because very few opportunities for the offering plate, especially missing at Easter and Christmas. The parish is grateful for the faithful support of many.

**Fundraising** (lines 93-95). These amounts are shown net of all expenses. There were few opportunities for fundraising during the pandemic.

The Concert Project (line 97). No concerts were held in 2021.

*Capital Maintenance* (lines 117). Planned capital maintenance was deferred in 2021 because of uncertainties caused by the pandemic.

**Outreach** (lines 105, 146-149). The parish was able to respond to the special needs in the midst of the pandemic because of the generosity of donors. The current Refugee Project was completed in 2021.

**Net Income** (line 172). The Income Statement shows a deficit of \$8,089 in 2021. It should be remembered this deficit occurs after a total of \$50,166 is transferred to investment funds, so that the parish in fact finished the year in a very positive position.

#### B-5: Subsequent Events

The coronavirus COVID-19 pandemic. The reality of the pandemic has had a significant impact upon church finances and ministries; however, the parish has managed well under the circumstances. Diocesan staff resources arranged for our application for assistance from the federal government and the Canada Employment Wage Subsidy (CEWS). CEWS payments concluded in August of 2021. Parishioners and community members have generously supported parish ministries. Despite the loss of income from the offering plate, there is a stable outlook for parish finances.

Maintenance and property matters. The church building and lease improvements in the Activity Center are dated and a number of ongoing maintenance and repairs are needed. A decennial inspection was completed in 2014 and a list of recommendations was provided in that report. The Corporation had established a property committee to prioritize items requiring immediate and short-term attention. Some of these items included: windows and frames; supply piping; fire protection; exterior doors; repair of Activity Centre air conditioner; and, replacement of an older

water heater, grounds; painting. Because of the coronavirus pandemic, however, no capital maintenance was undertaken in 2020 or 2021, meaning that there several significant deficits in the fabric of the building still wait to be addressed.

Accessibility project. Projects to improve the accessibility of our building were given approval in principle at the Annual Vestry meeting held in February 2020. Again, because of the coronavirus pandemic the work has not proceeded. In 2021 Parish Council renewed its interest in pursuing grant support for this project.

**Staffing.** The Annual Vestry of 2021 approved a budget that included provision of the hiring of a Coordinator of Children's Youth and Family Ministry. The new employee began her ministry in October.

Insurance. Due to many factors, including the effects of climate change and the increase of natural and human-caused disasters there has been a dramatic increase in the number and amounts of property insurance claims across Canada. We have been advised by our insurer through the Diocese of Niagara that we should expect an increase in premiums to be paid of approximately 10% in 2022 and subsequent years for the foreseeable future.

### Notes on the Budget

- a. **General note.** Budgeting in the present climate of the COVID-19 pandemic continues to be difficult. Neither income nor expense is very predictable under the circumstances. This budget is based upon the best assumptions that were available at the time of crafting the budget. One assumption is that while the present circumstances will persist for the beginning of 2022, some return to more normal patterns of income and expense may be possible as early as the second quarter of the year.
- b. **Diocesan Mission and Ministry (DM&M).** This expense is our parish fair share of diocesan expenses for mission. DM&M is tied to parish income less allowable expenses calculated on a three-year rolling average. The assessed amount for 2022 is as shown (line 73).
- c. **Staff salaries.** The Synod Council of the Diocese of Niagara recommended staff receive an increase for 2022 of 1.3% for cost-of-living plus and 0.6% increment for years of service, for a total of 1.9%. The churchwardens were uncomfortable accepting the cost-of-living

recommendation given the present rate of inflation. After discussion with Parish Council, it was agreed that the budget proposal would include a 4.0% increase in salary for all staff, (inclusive of cost-of-living and years of service increment).

- d. Canada Employment Wage Subsidy was discontinued in 2021.
- e. **Recommendation.** This ministry budget was prepared by the Corporation. It has been reviewed by Parish Council who recommended changes reflected in this proposal and is recommended by Corporation and Parish Council for adoption.

### **Hearts and Minds**

### Judith Purdell-Lewis

Middle Ground is a fellowship group of now 15 people that generally meets every other week for study, prayer, and, when possible, for food. We welcomed new members, Katherine McLean, Joan Hayhoe and Tom and Tania Hubschmid.

During the Covid-year of 2021, we met on Zoom until June, and again from October to December. During these online gatherings, we studied and discussed C.S. Lewis's book, The Great Divorce; finished a study in Luke that we had started in 2020; and looked at some chapters in Acts, using the Lectio Divina approach. Early in November, Tom Hubschmid led us in a Saturday afternoon Prayer Retreat. It was attended by most of the MG members and held on Bethany and Ed's back porch, where we enjoyed their wonderful pizza before we left.

We pray and care for our members in both their sorrows and joys. This year we supported Ed and Bethany through the sorrow of her sister's death, with meals, cards and prayer. The joys included a new baby, Brittany Friesen's acceptance into a Nursing Practitioner program and Clare Fiala's into McMaster Medical School. We welcomed baby Henri with a "Delivered Shower" for Jenna and Michael Bowering, sadly not an in-person gathering, and said goodbye to Brittany as she left for Kingston.

At Christmas, caring for the community, we raised enough money to fill four gift bags for St. Matthew's House seniors, which were put together by Jenna Bowering and Judith Purdell-Lewis.

### Stewardship Committee

The Lord answered, "Who then is the faithful and wise manager, whom the master puts in charge of his servants to give them their food allowance at the proper time? It will be good for that servant whom the master finds doing so when he returns" (Luke 12:42-43).

Stewardship refers to taking care of something, or managing it, and the term is used in various contexts -- such as environmental stewardship or the stewardship of heritage buildings. In our

faith community, stewardship refers to caring for what has been entrusted to us by God. As Christians, we are all called to be caretakers of God's kingdom.

The Stewardship Committee at St. John's has continued to pursue a broad approach to stewardship that focuses on how we follow Jesus and how we participate in God's mission. We have learned that stewardship is the intersection of prayer and action. Stewardship can look like giving financially to the church, but it is also how one gives of their time and talent. How are each of us using our time, talent, AND treasure to build inclusive and loving communities?

Our team has been working on seven areas to create a culture of stewardship in our congregation: stewardship education, shared decision making, community building, engaging volunteers, expression of thanks, financial ask, and prayer and discernment.

As we moved into the second year of the pandemic, we focused on a variety of ways to keep people connected to each other and to St. John's and our neighbours in need. We shared stories of gratitude and generosity, communicated the parish's financial health to parishioners, held a second food drive, and launched a working group to address volunteer resources. Despite the interruption of in-person worship and suspension of many church activities, we have been gratified to see that parish finances have benefited from sustained giving by many regular donors.

Committee members also made time to connect with each other, most notably by holding a mini planning retreat in the Anderson's backyard in August. Each member of our team read Lori Guenther Reesor's Growing a Generous Church: A year in the life of Peach Blossom Church, with subsequent discussion generating new ideas for our own stewardship plans.

### A Summary of 2021 Activities

**St. Matthew's House Food and Funds Drive, May.** Following on the highly successful May 2020 drive in support of St. Matthew's House seniors that raised \$8,600 and collected 1,500 pounds of food, we held a second similar drive in 2021. Originally scheduled for April 10, it was moved to May 29 due to another lockdown. We collected 630 pounds of food and about \$2,000.

**Sharing moments, Fall.** These short reflections by a parishioner offered during Sunday services focused on where people saw God and how their views of church changed during these isolating times. Thank you to Hal Devins, Luke Lima, and Deborah Bowen for providing these reflections. More will come in 2022.

**Sermons focused on stewardship**, preached by David Anderson, Graham Cubitt, and Gillian Doucet Campbell. In Gillian's Thanksgiving weekend sermon about the rich young man, she showed that the man was loved by Jesus, that he was working on creating a right relationship with God, and that we all have barriers holding us back from this relationship.

**Volunteer Resources Working Group, August to January.** To assist people with using their time and talent at St. John's, the working group was convened in August to identify and collect various resources needed for effective volunteer ministry. This group completed its final report in January

2022. The final report contains sections on Diocesan Policies and Procedures, Organization Chart, Job Descriptions, Volunteer Recruitment, Volunteer Training and Orientation, and Volunteer Appreciation. The Stewardship Committee extends our thanks to this working group for its important groundwork. Chaired by Kate Connolly, its members were Clare Fiala, Luke Lima, Adrienne Devins, Sharon Klassen, and Emily Hill (co-chair). We currently seek volunteers to form a task group to implement the recommendations that were identified in the report.

**Parish mailing, October.** In this annual mailing, our team drafted a letter to parishioners and requested that people prayerfully consider and submit their financial intentions for the coming year.

The Soul of Money Book Study, October-November. Led by Susan Little and Graham Cubitt, this book group met three times. In this book, author Lynne Twist shows the links between our values and our attitudes towards money and where we spend it. This book is about finding a new freedom, truth, and joy in our relationship with money whatever our circumstances.

**Thank you notes, December-January.** Using newly-designed parish notecards, our churchwardens wrote thank-you notes to all households that made a financial commitment to St John's for 2022. Names were furnished by the parish envelope secretary as she and the rector are the only persons who have access to donor information.

### Bibles and Bagels Group
